Unpacking Antisemitism & Anti-Zionism After October 7th. Since October 7th, antisemitic incidents have soared to the highest levels since 1979, when the Anti-Defamation League started tracking the data. Of the record-setting number of antisemitic incidents in 2023, 36 percent specifically referenced Israel or Zionism. On college campuses, Hillel reports a staggering 700% increase in antisemitic incidents since last year. At this event, you'll hear from Scott Galloway, a five-time *New York Times* bestselling author, nine-time serial entrepreneur, top-rated Professor of Marketing at NYU's Stern School of Business, award-winning podcaster, and board member to multiple public companies. In addition, since October 7th, Scott has become one of the most influential voices fighting antisemitism. Scott will break down for us the trigger words, phrases, and truths about what transpired on October 7th and he'll weigh in on whether Israel is being held to a different standard than other countries and Iran proxies, including Hamas. We'll uncover what's behind the rampant antisemitism on college campuses and we'll debate whether there's a difference between antisemitism and anti-Zionism and whether the two have become conflated through social media and otherwise. With probing questions posed by author, workplace expert, and advocate Debbie Epstein Henry, Scott will bring nuance, understanding, and compassion to these highly charged issues as well as share strategies to combat antisemitism in our workplaces and beyond and speak out against all forms of hate.
