





Debbie Epstein Henry is a lawyer turned entrepreneur, author, and public speaker with an expertise in women, careers, workplace dynamics and law. Debbie runs <u>DEH Consulting</u>, <u>Speaking</u>, <u>Writing</u> and consults with and speaks at private retreats, public events and conferences for companies, law firms and other professional service firms as well as non-profits. Her international work includes multiple engagements in The Hague as well as in Paris at the French Senate and in London and Vienna and other cities abroad.

Debbie runs the <u>DEH Speaker Series</u>, offering virtual programming with *New York Times* best-selling authors, TED speakers, and thought leaders, that draws hundreds to 1,000+ participants per quarter. She is also the host of the podcast, <u>Inspiration Loves Company</u>, where she explores how to do better and be better at life, work and everything in-between.

Debbie wrote two best-selling books, *Law & Reorder* (author) and *Finding Bliss* (co-author). Hundreds of news outlets have featured her work including *The New York Times*, NBC Nightly News, *The Wall Street Journal* and National Public Radio. Through Debbie's public speaking, press exposure and advocacy, she built a national network of over 10,000 lawyers. From there, in 2011, she co-founded Bliss Lawyers, a company that employed high caliber attorneys to work on temporary engagements for in-house legal department and law firm clients. In 2020, Debbie co-facilitated the successful acquisition of Bliss Lawyers by its largest competitor, Axiom, the global leader in high-caliber, on-demand legal talent.

Debbie volunteers her time with a number of non-profits. She is the immediate past president and board chair of The Forum of Executive Women, a nomination-only, membership organization of the top 600 women in business in the greater Philadelphia region. She is also the co-founder and chair of Brooklyn Law School Women's Leadership Circle which runs the Women's Leadership Network, a national women's law student and alumnae initiative. Debbie has received numerous awards including being named among the *Philadelphia Business Journal*'s "Women of Distinction." In 2017, she received the Anne X. Alpern Award, presented annually to a female lawyer who demonstrates excellence in the legal profession and who makes a significant professional impact on women in the law. Debbie received her B.A. from Yale. She received her J.D., *cum laude*, from Brooklyn Law School. A native New Yorker, Debbie and her husband recently returned to the New York area; they have three grown sons.
