In 2009, NASDAQ named her its top general counsel. Paula's prior professional experience includes serving as Vice President, Legal at Dell Computer Corporation and as a law firm partner. She also had a 14-year career in public service, including as an Assistant U.S. Attorney, and in various capacities as an attorney for the U.S. Army, the Department of Defense and the White House Office of Legal Counsel. Since leaving Starbucks, Paula gives speeches, writes essays and music, co-produces albums for, and tours extensively with the Paula Boggs Band. Some of her current civic and professional activities include: Avid Technology, Inc.; Seattle Symphony; American Bar Foundation;

Peabody Institute of The Johns Hopkins University National Advisory Board; and, YMCA of Greater Seattle. She has been recognized by countless organizations including: serving on President Obama's Committee on the Arts and the Humanities; being named to Savoy Magazine 2021 List of Most Influential Black Corporate Board Directors; receiving the Johns Hopkins University Distinguished Alumnus(a) Award; receiving an Honorary Doctorate of Laws, Southwestern University degree in 2021, and much more.
